

BAC Resolution Declaring LDC and Recommending Award

WHEREAS, the PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-107 re: PROVISION OF ACCOMMODATION MEALS AND SNACKS FOR THE PARTICIPANTS, FACILITATORS & SPEAKERS FOR THE EMERGENCY OPERATIONS CENTER (EOC) TRAINING COURSE with an ABC of ₱ 414,100.00;
