THIS AGREEMENT, made this 23<sup>rd</sup> day of July, 2021 between Provincial Disaster Risk Reduction and Management Office of Provincial Government of Bohol (hereinafter called the "Entity") and BELLE SOUTH PACIFIC PROPERTIES, INC. of Doljo, Panglao, Bohol (hereinafter called the "the Supplier").
