WHEREAS, the CONG. SIMEON G. TORIBIO MEMORIAL HOSPITAL, CARMEN, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 – 250 re: PROCUREMENT OF ALCOHOL, SYRINGES, & GLOVES with an ABC of P 573,040.00;






