**WHEREAS**, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. \_\_\_\_\_ series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **PROVINCIAL GOVERNMENT OF BOHOL** in undertaking Procurement Request under PR No. **2021-C-096** re: **BULK PROCUREMENT OF CATERING AND ACCOMMODATION SERVICES FOR THE DIFFERENT ACTIVITIES AND EVENTS OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR THE 2<sup>nd</sup> QUARTER OF CY 2021 – A. EVENTS/ ACTIVITIES/ PROGRAMS INVOLVING FOREIGN AND NATIONAL DIGNITARIES AND VIPS** with an ABC of **₱ 555,000.00**;
