SIMEON G. TORIBIO MEMORIAL HOSPITAL, CARMEN, BOHOL** in undertaking Procurement Request under **PR No. – PHO – 2021 - 185** re: **PROCUREMENT OF TIRES FOR AMBULANCE PLATE NO. NFZ - 8807** with an ABC of **P 38,400.00**;


**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:


