THIS AGREEMENT, made this 25 AUG 2021 day of _____, 2021 between Office of the Provincial Agriculturist of Provincial Government of Bohol (hereinafter called the "Entity") and ELEBO CONSTRUCTION AND SUPPLY of San Isidro, Calape, Bohol (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **CONSTRUCTION OF SHED HOUSE TO PROVIDE STORAGE WASHING & PACKING HOUSE TO THE BENEFICIARY FARMERS** (hereinafter called "the Works") and the Entity has accepted the Bid for **₱ 297,878.47 in Two Hundred Ninety Seven Thousand Eight Hundred Seventy Eight Pesos and Forty Seven Centavos Only** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

WHEREAS, Project shall be completed in 120 Calendar Days in accordance with the provisions of the Bid Documents;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

3. In consideration for the sum of **Two Hundred Ninety Seven Thousand Eight Hundred Seventy Eight Pesos and Forty Seven Centavos Only** or such other sums as may be ascertained, **Mr. Gavino O. Cubillo, Jr.** agrees to **CONSTRUCTION OF SHED HOUSE TO PROVIDE STORAGE WASHING & PACKING HOUSE TO THE BENEFICIARY FARMERS** in accordance with his/her/its Bid.

4. The **Office of the Provincial Agriculturist** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

5. In consideration of the payments to be made by the Owner to the Contractor, as earlier mentioned, the Contractor hereby covenants with the Owner to implement and complete the Project in conformity with the provisions of the Contract, the documents incorporated herein and the laws and regulations made integral parts hereof.

6. The Owner hereby covenants to pay advance payment to the Contractor of 15% of the total contract price upon approval of the Contract, issuance of Notice to Commence Work and the posting of irrevocable standby letter of credit of equivalent value. The Contractor hereby covenants to repay advance payment to the Owner by deducting 15% from his progress payment.
