WHEREAS, in the detailed evaluation of bids JOSMEF ENTERPRISES was declared as the Lowest Calculated Bid as Read and was recommended for post qualification;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, JOSMEF ENTERPRISES was recommended for disqualification due to the reason; 1.) Failure to met the Technical Specification required by the End User;

WHEREAS, in the detailed evaluation of bids DEXTEL TRADING as the Second Lowest Calculated Bid as Read was recommended for post qualification process;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, DEXTEL TRADING met the required legal, technical and financial requirements for the said project

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by DEXTEL TRADING the bidder, declared as the **SECOND LOWEST CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **LOWEST COMPLYING and RESPONSIVE BID** for the said project;
