WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0145-A series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **BOHOL ENVIRONMENT MANAGEMENT OFFICE** in undertaking Procurement Request under PR No. 2021-0170 re: Procurement of Diesel Fuel and Diesel Engine Oil for the Service Vehicles and Equipment for use at Bohol Environment Management Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 293,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOP** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:




