WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 – 229 re: PROCUREMENT OF GARBAGE BAGS with an ABC of P297,600.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 32 TRADING POST offered the Single price quotation as reflected in the Abstract of Bid Quotations,
