BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL PLANNING AND DEVELOPMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0517; re; Procurement of Diesel & Lubricants, by the Provincial Planning and Development Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 105,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PETROBEST (PETRON) SERVICENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
