

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0123, re: Procurement of Various Office Supplies, Janitorial Supplies and Ink Toners for use at Provincial Economic Enterprise Management Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 79,383.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that offered the lowest price quotation among the suppliers as reflected in the Abstract of bid Quotations;

- b.) To recommend award to DELMA ENTERPRISE for the delivery of goods/services under Negotiated Canvass No. 2021-0074 in the amount of P 79,038.75;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


