WHEREAS the PROVINCIAL DISASTER RISK REDUCTION & MANAGEMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0499, re; Procurement of CAT5 Data Cable, RJ45 Connector, Modular Plug Single, Modular Plug Double, Crimping Tool, Transfer/Pull Down Antenna Towers & Repeaters, by the Provincial Disaster Risk Reduction & Management Office, Camp Bernido Compound, Dao District, Tagbilaran City, with an ABC of P 323,964.00;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


