

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE BOARD MEMBER ROMULO G. CEPEDOZA, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0522 re. Procurement of Spare Parts and Labor for the repair/ replacement of worn-outs parts service vehicle Mitsubishi Strada with Plate No. SKY-356 used at the Office of the Board Member Romulo G. Cepedoza, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol. with an ABC of P 264,105.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES & SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of bid Quotations;
