WHEREAS, the OFFICE OF THE SP-BOARD MEMBER ELPIDIO L. BONITA, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0510; re; Procurement of Office Supplies, by the Office of the Board Member Elpidio L. Bonita, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol, with an ABC of P 75,216.93;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that offered the lowest price quotation among the suppliers as reflected in the Abstract of bid Quotations;
