

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Procurement Requests No. 2021-0387, re: Procurement of Executive Table with Small Cabinet, Executive Chair & Hot & Cold Dispenser, by the Office of the Governor, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 59,550.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that GOLDEN AI TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of bid Quotations;






