WHEREAS, the PROVINCIAL ENGINEER'S OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. 2021-0267 re: Procurement of Toner Cartridge (CE 285A) for used at Provincial Engineer's Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 85,800.00;


WHEREAS, the above Procurement Request was presented to the BIDS AND AWARDS COMMITTEE for deliberation and proper action;
