

BAC Resolution Recommending the Use of Alternative Mode of through Direct Contracting, Declaring Single Canvasser and Responsive Quotation and Recommending Approval

WHEREAS, the above Procurement Request was presented to the BIDS AND AWARDS COMMITTEE for deliberation and proper action;



- c) To recommend approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




