WHEREAS, the **PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. **2021 – 222** re: **Procurement of STEEL BEDS, FOAM MATTRESS, ELECTRIC FANS, AND WATER DISPENSER** with an ABC of **P 1,248,250.00**;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **GOLDEN AI TRADING** offered the Single price quotation as reflected in the Abstract of Bid Quotations,
