WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. PHO – 2021 – 230 re: PROCUREMENT OF OXYGEN CANNULA ADULT, DIAPERS & RAPID ANTIGEN with an ABC of ₱ 449,800.00;
