WHEREAS, the **PROVINCIAL HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2021-C-125** re: **PROVISION OF CATERING SERVICES DURING THE SPMS ORIENTATION AND WORKSHOP FOR THE PGBH NEWLY HIRED EMPLOYEES INCLUDING PLANTILLA PERSONNEL** with an ABC of **₱ 104, 500.00**;
