WHEREAS, the **CLARIN COMMUNITY HOSPITAL, CLARIN, BOHOL**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under **Purchase Requests No. - PHO - 2021 - 088** re: **PROCUREMENT OF VARIOUS OFFICE SUPPLIES ABC of P 75,750.00;**


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **MSO OFFICE SUPPLIES AND EQUIPMENT TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **MSO OFFICE SUPPLIES AND EQUIPMENT TRADING** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **MSO OFFICE SUPPLIES AND EQUIPMENT TRADING** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- a.) To declare **MSO OFFICE SUPPLIES AND EQUIPMENT TRADING** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount **P 55,370.00** for the **DELIVERY OF GOODS/SERVICES** under **Negotiated Canvass No. - PHO - 2021 - 072**;
- b.) To recommend award to **MSO OFFICE SUPPLIES AND EQUIPMENT TRADING** in the amount of **FIFTY FIVE THOUSAND THREE HUNDRED SEVENTY PESOS ONLY (P 55,370.00)** for the delivery of goods under **Negotiated Canvass No. - PHO - 2021 - 072**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings




