



BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL GENERAL SERVICES OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-0045 re: RENOVATION AND IMPROVEMENT OF OLD SEEM OFFICE, GOVERNOR'S MANSION COMPOUND FOR THE USE AT GOVERNOR'S OFFICE, with an ABC of ₱ 374,888.92;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that INABANGA DRILLING, CONSTRUCTION, STEEL FABRICATION & GENERAL MERCHANDISE offered the lowest price quotation among the contractors as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of INABANGA DRILLING, CONSTRUCTION, STEEL FABRICATION & GENERAL MERCHANDISE including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, INABANGA DRILLING, CONSTRUCTION, STEEL FABRICATION & GENERAL MERCHANDISE has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a). To declare INABANGA DRILLING, CONSTRUCTION, STEEL FABRICATION & GENERAL MERCHANDISE as the supplier/contractor with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for the GOODS/SERVICES under Negotiated Canvass No. INF-2021-0029;
- b). To recommend award to INABANGA DRILLING, CONSTRUCTION, STEEL FABRICATION & GENERAL MERCHANDISE for the goods/services of the aforementioned request in the amount of ₱ 374,256.25;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
