WHEREAS, the PROVINCIAL GENERAL SERVICES OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-0045 re: RENOVATION AND IMPROVEMENT OF OLD SEEM OFFICE, GOVERNOR'S MANSION COMPOUND FOR THE USE AT GOVERNOR'S OFFICE with an ABC of # 374,888.92;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that INABANGA DRILLING, CONSTRUCTION, STEEL FABRICATION & GENERAL MERCHANDISE offered the lowest price quotation among the contractors as reflected in the Abstract of Bids Proposals:
