WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2021-0866 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **BOHOL EMPLOYMENT & PLACEMENT OFFICE** in undertaking Procurement Request under PR No. 2021-0425 re: Procurement of Various Office Supplies, by the Bohol Employment & Placement Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol. with an ABC of ₱ 37,602.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **DELMA ENTERPRISE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;




