



BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the **PROVINCIAL GENERAL SERVICES OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2021-0046** re: **PROCUREMENT OF PROPOSED COMFORT ROOM INSIDE GOVERNOR'S MANSION COMPOUND FOR USED AT GOVERNOR'S OFFICE** with an ABC of **P 750,892.19**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **INABANGA DRILLING, CONSTRUCTION, STEEL FABRICATION & GENERAL MERCHANDISE** offered the lowest price quotation among the contractors as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of **INABANGA DRILLING, CONSTRUCTION, STEEL FABRICATION & GENERAL MERCHANDISE** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, **INABANGA DRILLING, CONSTRUCTION, STEEL FABRICATION & GENERAL MERCHANDISE** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a). To declare **INABANGA DRILLING, CONSTRUCTION, STEEL FABRICATION & GENERAL MERCHANDISE** as the supplier/contractor with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** for the **GOODS/SERVICES** under Negotiated Canvass No. **INF-2021-0030**;
- b). To recommend award to **INABANGA DRILLING, CONSTRUCTION, STEEL FABRICATION & GENERAL MERCHANDISE** for the goods/services of the aforementioned request in the amount of **P 750,092.46**;
- c). To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
