

## **BAC Resolution Declaring LCRQ and Recommending Award**

WHEREAS, the <u>PROVINCIAL GENERAL SERVICES OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL</u> made procurement under Purchase Request No. <u>2021-0046</u> re: <u>PROCUREMENT OF PROPOSED COMFORT ROOM INSIDE</u> <u>GOVERNOR'S MANSION COMPOUND FOR USED AT GOVERNOR'S OFFICE</u> with an ABC of <u>P 750,892.19</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>INABANGA</u>
