CONTRACT AGREEMENT

THIS AGREEMENT, made this 8TH day of April, 2021 between the Provincial Government of Bohol (hereinafter called the "Entity") and REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. of 0067 Brunidor St., Cogon District, Tagbilaran City, Bohol (hereinafter called the "the Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the *Bulk Procurement of Catering and Accommodation Services for the Different Activities and Events of the Provincial Government of Bohol for the 1st Quarter of CY 2021 - C. Trainings/ Seminars/ Workshops and Consultative Meeting and Other Capacity-Building Related Activities - Within Tagbilaran for Item nos. 1, 4, 7 & 10* and has been accepted a Bid by the Supplier for the supply of those goods and services in the sum of ₱ 1,473,071.00 in *One Million Four Hundred Seventy-Three Thousand Seventy-One Pesos Only*.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of the Contract; and;
 - iv. Supplemental or Bid Bulletins, if any;
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty**
