WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILLARAN CTM of the FROM GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 099 ft.
