

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

> RESOLUTION NO. 2021- 265 Series of 2021

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 226 re: PROCUREMENT OF VARIOUS LABORATORY SUPPLIES ABC of P 363,343.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,
