

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY, of the PROVINCIA GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 280 re: PROCUREMENT OF VEHICLE
