


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to ST. JUDE PRESS MARKETING AND SUPPLIES in the amount of TWO HUNDRED ONE THOUSAND EIGHT HUNDRED THIRTY SIX PESOS AND 75/100 (P 201,836.75) for the delivery of goods under Negotiated Canvass No. - PHO - 2021 - 205;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings


