WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2021-0541-A series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL GOVERNMENT OF BOHOL in undertaking Procurement Request under PR No. 2021-C-100 re: BULK PROCUREMENT OF SERVICES FOR THE DIFFERENT ACTIVITIES AND EVENTS OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR THE 3RD QUARTER OF CY 2021 – D. OTHER ACTIVITIES (PACKED MEAL) with an ABC of P 4, 753, 675.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PANDA TEA GARDEN SUITES as the lowest calculated and responsive quotation for item nos. 2, 3, 6, 8, 9 & 11, REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. as the lowest calculated and responsive quotation for item no. 12, CASA REY FRANCIS PENSION HOUSE AND RESTAURANT as the lowest calculated and responsive quotation for item nos. 4, 7 & 13 and ALTA CEBU VILLAGE GARDEN RESORT, INC. as the lowest calculated and responsive quotation for item nos. 1, 5, 10 & 14 as reflected in the Abstract of Bid Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, PANDA TEA GARDEN SUITES, REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC., CASA REY FRANCIS PENSION HOUSE AND RESTAURANT and ALTA CEBU VILLAGE GARDEN RESORT, INC. have been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

To declare PANDA TEA GARDEN SUITES for item nos. 2, 3, 6, 8, 9 & 11, REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. for item no. 12, CASA REY FRANCIS PENSION HOUSE AND RESTAURANT for item nos. 4, 7 & 13, and ALTA CEBU VILLAGE GARDEN RESORT, INC. for item nos. 1, 5, 10 & 14 as the suppliers with the Lowest and Responsive Price Quotation per Item for the Delivery of Catering and Accommodation Services under Negotiated Canvass No. 2021-101 (2nd Failure);

To recommend award PANDA TEA GARDEN SUITES in the total amount of P1,033,960.00 REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. in the total amount of P1,379,854.00, CASA REY FRANCIS PENSION HOUSE AND RESTAURANT in the total amount of P1,174,092.00 and ALTA CEBU VILLAGE GARDEN RESORT, INC. in the total amount of P1,066,480.00 for the delivery of Catering Services under Negotiated Canvass No. 2021-101 (2nd Failure);
