RESOLUTION NO. <u>21-0715</u> Series of 2021

WHEREAS, the OFFICE OF THE SANGGUNIANG PANLALAWIGAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-147 re: PROVISION OF MEALS & ROOM ACCOMMODATION FOR USE DURING THE REVIEW/REVISION OF THE SANGGUNIANG PANLALAWIGAN OF BOHOL INTERNAL RULES AND PROCEDURES with an ABC of P 162,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>THE BELLEVUE</u> <u>RESORT</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of THE BELLEVUE RESORT including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, THE BELLEVUE RESORT has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a). To declare THE BELLEVUE RESORT as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for the CATERING SERVICES & ACCOMMODATION under Negotiated Canvass No.21-116;
- b). To recommend award to <u>THE BELLEVUE RESORT</u> for the Catering Services & Accommodation of the aforementioned request in the amount of <u>P 162,500.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
