



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 124 re: PROCUREMENT OF I.T. EQUIPMENT & BAR STOOL CHAIR ABC of P 87,000.00;



- b) To recommend award to B & J COMPUTER SALES AND ELECTRONIC SERVICES INC. in the amount of EIGHTY FIVE THOUSAND SIX HUNDRED EIGHTY PESOS ONLY (P 85,680.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2021 - 095;
- c) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings


