WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0304 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL AGRICULTURIST in undertaking Procurement Request under PR No. 2021-0331 re: Procurement of Digital Commercial Weighing Scale, Commercial Mechanical Weighing Scale, Garden Fruit Pruning Shears Grafting Cutting Tool Snip Machine Scissor Kit Set, Professional Pole Planner Machine, Powerful Cordless Telescopic Pole Pruner, Wheel Barrow Heavy Duty Standard Size & Planting Auger, by the Office of the Provincial Agriculturist, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of ₱ 728,800.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 3 MSG ENTERPRISES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, 3 MSG ENTERPRISES has been found to be ELIGIBLE and its quotation, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:


