WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0406, series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode, and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL LEGAL OFFICE in undertaking Procurement Request under PR No. 2021-0533 re: Procurement of Various Vehicle, Oil & Anti Corrosive Fluids, by the Provincial Legal Office, Bohol Provincial Capitol Building, Cocon District, Tagbilaran City, Bohol, with an ABC of ₱ 33,200.00;




