

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 293 re: PROCUREMENT OF TUBELESS TIRES, DIESEL OIL, COOLANT & SPARE PARTS with an ABC of P 233,660.00.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that JAN SURPLUS CENTER, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

- b.) To recommend award to JAN SURPLUS CENTER, for the delivery of goods under Negotiated Canvass No. - PHO - 2021 - 222, in the amount of **TWO HUNDRED THIRTY THREE THOUSAND FIVE HUNDRED FORTY ONE PESOS AND 75/100** P 233,541.75;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings




