WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0146-A series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL AGRICULTURIST NUTRITION in undertaking Procurement Request under PR No. 2021-0130 re: Procurement for Desktop Computer, and 3 in 1 Printer for used of the Office of the Provincial Agriculturist - Nutrition, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City., with an ABC of ₱ 60,000.00;

- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


