BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the BOHOL TOURISM OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-150, re: PROVISION OF ACCOMMODATION AND MEALS FOR THE VOLUNTEERS AND VACCINATORS OF THE TOURISM FRONTLINERS IN BOHOL with an ABC of ₱ 594,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BELLE SOUTH PACIFIC PROPERTIES/THE BELLEVUE RESORT offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of BELLE SOUTH PACIFIC PROPERTIES/THE BELLEVUE RESORT including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, BELLE SOUTH PACIFIC PROPERTIES/THE BELLEVUE RESORT has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a). To declare BELLE SOUTH PACIFIC PROPERTIES/THE BELLEVUE RESORT as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for the CATERING AND ROOM ACCOMMODATION SERVICES under Negotiated Canvass No. 21-119;
- b). To recommend award to BELLE SOUTH PACIFIC PROPERTIES/THE BELLEVUE RESORT for the Catering and Room Accommodation Services of the aforementioned request in the amount of ₱ 594,000.00;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
