

## BAC Resolution Declaring LCRQ and Recommending Award

RESOLUTION NO. 2021-0656 Series of 2021

WHEREAS, the <u>BOHOL TOURISM OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL made procurement under</u> Purchase Request No. 2021-C-150 re: <u>PROVISION OF ACCOMMODATION AND MEALS FOR THE VOLUNTEERS AND VACCINATORS OF THE TOURISM FRONTLINERS IN BOHOL</u> with an ABC of <u>P 594,000.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BELLE SOUTH PACIFIC PROPERTIES/THE BELLEVUE RESORT</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>BELLE SOUTH PACIFIC PROPERTIES/THE BELLEVUE RESORTINGUIDING</u> the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, <u>BELLE SOUTH PACIFIC PROPERTIES/THE BELLEVUE RESORT</u> has been found to be <u>ELIGIBLE</u> and its bid, <u>RESPONSIVE</u>;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a). To declare <u>BELLE SOUTH PACIFIC PROPERTIES/THE BELLEVUE RESORT</u> as the bidder with the <u>LOWEST CALCULATED AND RESPONSIVE QUOTATION</u> for the <u>CATERING AND ROOM ACCOMMODATION SERVICES</u> under Negotiated Canvass No.21-119;
- b). To recommend award to <u>BELLE SOUTH PACIFIC PROPERTIES/THE BELLEVUE RESORT</u> for the Catering and Room Accommodation Services of the aforementioned request in the amount of <u>P 594,000.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
