WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-172 re: PROVISION OF MEALS AND SNACKS DURING THE AWARDING OF LUPONG TAGAPAMAYAPA INCENTIVES AWARD with an ABC of P 69, 300.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ALTA CEBU VILLAGE GARDEN RESORT, INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
