BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. **2021 – 308** re: **Procurement of various MEDICINES** with an ABC of **P 4,913,400.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **DEXTEL TRADING** offered the Single price quotation as reflected in the Abstract of Bid Quotations,
