

BAC Resolution Declaring SORC through Negotiated Method of Procurement - Emergency Cases
and Recommending Award

WHEREAS, the CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL, UDON, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. PHO - 2021 - 385 re: PROCUREMENT OF MEDICAL SUPPLIES with an ABC of ₱ 1,287,575.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement - Emergency Cases showed that DEXTEL TRADING, offered the single price quotation as reflected in the Abstract of Bids Proposals;


WHEREAS, pursuant to Section 53.2 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of DEXTEL TRADING, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, DEXTEL TRADING, has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a). To declare DEXTEL TRADING, as the bidder with the **SINGLE CALCULATED AND RESPONSIVE QUOTATION** for the DELIVERY OF GOODS under Negotiated Canvass No. PHO - 2021-311 (Emergency Cases);
- b). To recommend award to DEXTEL TRADING, for the delivery of goods of the aforementioned request in the amount of ₱ 1,287,575.00; except for item no. 4, having no quotation from the supplier is recommended for PETTY CASH.
- c). To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.


