WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL OVERSEA COMMERCIAL offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


