



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PADMO-PROVINCIAL PROCUREMENT MANAGEMENT UNIT, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0599; re; Procurement of Multicopy Papers & Computer Ink, by the Office of the Provincial Procurement Management Unit, New Capitol Compound, Tagbilaran City, with an ABC of P 169,565.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 3 MSG ENTERPRISES offered the lowest price quotation among the suppliers as reflected in the Abstract of bid Quotations;

- b.) To recommend award to 3 MSG ENTERPRISES for the delivery of goods/services under Negotiated Canvass No. 2021-0414, in the amount of P 169,228.30;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


