

WHEREAS, the **PROVINCIAL MOTOR POOL OFFICE**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. 2021-0716; re; Procurement of Vehicle Spare Parts for the Road Grader, by the Provincial Motor Pool, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 213,525.00;




