BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring L Responsive Quotation and Recommending Approval

WHEREAS, the TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 189 re: PROCUREMENT OF VARIOUS APPLIANCES with an ABC of P 447,135.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PARK AVENUE GENERAL MERCHANDISE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of PARK AVENUE GENERAL MERCHANDISE including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid PARK AVENUE GENERAL MERCHANDISE has been found to be ELIGIBLE and its bid, RESPONSIVE;
