

BAC Resolution Declaring Single Complying and Responsive Bid and Recommending Approval

WHEREAS, the PROVINCIAL GOVERNMENT OF BOHOL caused the advertisement and posting of invitation to Bid in the Newspaper, PHILGEPS Website, Provincial Government Website and at three (3) conspicuous places in the premises of the Provincial Capitol Complex, Tagbilaran City of the hereunder project:

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and certifying of all statements made and documents submitted by BYRO PHARMA the bidder declared as the SINGLE CALCULATED BID, successfully passed the Post Qualification process, thus the Committee now considered BYRO PHARMA as the SINGLE CALCULATED and RESPONSIVE BID for the said project;

NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby DECIDED:

- a.) To declare BYRO PHARMA as the SINGLE CALCULATED and RESPONSIVE BID in the amount of P 256,970.20 for the Procurement of MEDICAL AND SURGICAL SUPPLIES under Project Reference No.- PHO - 2021 – 068;
