Recommending Approval

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. _____ series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the Provincial Diagnostic & Ambulatory Care Center, Tagbilaran City in undertaking Procurement Request under PR No. - PHO - 2021 - 197 re: PROCUREMENT OF EXECUTIVE TABLE, CHAIRS, & STEEL CABINET with an ABC of P 110,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 5 ANGELS TRADING offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53 of the implementing Rules and Regulations of R.A. 9184, 5 ANGELS TRADING has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- To declare 5 ANGELS TRADING as the supplier with the Lowest and Responsive Price Quotation in the amount of P 109,835.00 under Negotiated Canvass No. - PHO - 2021 - 209 (2nd failure of bidding);
- To recommend award 5 ANGELS TRADING in the amount of ONE HUNDRED NINE THOUSAND EIGHT HUNDRED THIRTY FIVE PESOS ONLY (P 109,835.00) for the Delivery of Goods under Negotiated Canvass No. - PHO - 2021 - 209 (2nd failure of bidding);
- To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


