

- b.) To recommend award to PRIM E CONSTRUCTION SUPPLIES TRADING in the amount of EIGHTY SEVEN THOUSAND TWENTY FIVE PESOS ONLY (P 87,025.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2021 - 223;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
